HOW DO I REGISTER?

- 1| Go to the Zoomgov [Registration site](#).
- 2| Complete the form. *Please make sure to enter a valid contract ID for your organization.* This ensures we have all the information necessary to make registration determinations.
- 3| Click on “Register.”

WHO SHOULD ATTEND?

All attendees must register using a valid contract ID for the current or upcoming year and from a represented organization such as:

- Medicare Advantage Organizations (MAOs)
- Program of All-Inclusive Care for the Elderly (PACE)
- Cost Plans
- Certain Demonstration Projects (MMPs, etc.)
- Third Party Submitters supporting MAOs
