[Register](#)**NEW Integrated Learning System (ILS) EVENT: Safety Across the Board (SAB): Hospital Safety as a Team Sport**

Hospitals need to create a culture of safety, one that engages multiple stakeholders in efforts to eliminate all harm for all people. The strongest cultures support employee engagement at all levels, promoting open communication and the sharing of mistakes to foster improvement. SAB presents a “new norm” for hospital safety by encouraging a shift away from a project-by-project approach to safety, to a focus on reducing all potential forms of harms occurring in the hospital setting. The SAB approach implements a systematic method to address and reduce all harms simultaneously. SAB is a framework of fundamental concepts every hospital executive, clinician, frontline staff, and administrator can commit to in order to reduce harms and provide safe care.

The ILS event will introduce CMMI model participants to the concept of SAB. The webinar will also highlight Parrish Medical Center and White Plains Hospital, two hospitals enrolled in Partnership for Patients that have demonstrated success in various elements of SAB.
