Medicaid Plans

Attached to this memorandum is the final Contract Year (CY) 2022 Marketing Guidance for Medicare-Medicaid Plans (MMPs) operating in the Illinois capitated financial alignment model demonstration. CMS and Illinois jointly updated the Marketing Guidance for Illinois MMPs, in accordance with provisions of the Three-Way Contract.

CMS recently codified guidance contained in the Medicare Communications and Marketing Guidelines by integrating it with existing regulations.<sup>1</sup> Although the codified marketing and communications policies are not new policies, we updated the Marketing Guidance for Illinois MMPs to accurately reference the applicable regulations, follow the section numbers and headings used in the regulations, and incorporate state-specific modifications.

The Marketing Guidance provides information only about those sections of the regulations that are not applicable to or that are clarified for MMPs in Illinois. The Marketing Guidance is applicable to all Illinois MMP marketing for CY 2022 benefits.
