# Section 1557 of the Affordable Care Act: Fighting Discrimination, Promoting Health.

### Background

On April 26, 2024, the HHS Office for Civil Rights (OCR) issued a final rule under Section 1557 of the Affordable Care Act (ACA) advancing protections against discrimination in health care. Section 1557 prohibits discrimination on the basis of race, color, national origin, sex, age, or disability in health care programs or services that get money from the federal government and state-based health insurance Exchanges. It is one of the federal government's most powerful tools to ensure nondiscriminatory access to health care.

By taking bold action to strengthen protections against discrimination, this rule reduces language access barriers, requires physical and digital accessibility, tackles bias in health technology, and much more.

### **Key Messages**

Here are some key messages for your use when communicating about the 2024 Section 1557 final rule:

### **1** Section 1557 is the heart and soul of the Affordable Care Act.

Meaningful access to health care requires that all people regardless of who they are or where they come from are not discriminated against when it comes to seeing the doctor or getting health insurance.

**2** You don't shed your civil rights at the hospital door.

Section 1557 of the ACA prohibits health care providers, hospitals, insurers and more from discriminating against you because of your race, color, national origin, sex, age, or disability.

# All people deserve health care that is safe, culturally competent, and free from discrimination.

This rule helps increase meaningful access to health care for communities across the country. The rule makes clear that health care should be accessible to people with disabilities, requires qualified interpreters and translators for individuals with limited English proficiency, and protects against discrimination as a result of the use of artificial intelligence.

#### Section 1557 is one of the federal government's strongest tools to protect the right to nondiscrimination in health care for everybody and every body.


