2024 NATIONAL OVERVIEW



KEY FACTSAT-A-GLANCE

Disaggregated data, or detailed origin data, reveal significant community needs that are often hidden or masked by averaged racial data for Asian Americans, Native Hawaiians, and Pacific Islanders (AA and NHPIs).

EDUCATION

There are stark differences in educational attainment among AA and NHPI communities. The following groups are among those least likely to have completed an associate's degree or higher: Marshallese, Bhutanese, Samoan, Burmese, Laotian, Tongan, Native Hawaiian, Cambodian, Fijian, Chamorro, Hmong, and Vietnamese.

POVERTY

- ➤ One in 10 Asian Americans lives in poverty, and 12.3% live below 200% of the federal poverty line, making them eligible for many state programs.
- ➤ Poverty is high among Native Hawaiians and Pacific Islanders (16.3%), and among Burmese, Bangladeshi, Mongolian, and Nepalese Americans.

LANGUAGE ACCESS

- Asian Americans have among the highest language access needs of any racial group (27.9%). This is related to their high rates of immigration (74.6% are foreign-born, and most foreign-born persons have arrived after 2000).B
- Native Hawaiians and Pacific Islanders also have significant language access needs, as 11.8% are limited English proficient, meaning that they speak English less than "very well."

HOUSING

- ➤ Many detailed Asian American, Native Hawaiian, and Pacific Islander groups have homeownership rates below the U.S. average.
- ➤ Asian American and NHPI individuals are more likely than the U.S. average to live in multi-generational households.










10. HOME OWNERSHIP RATES
